- I. <u>Call Meeting to Order:</u> Amana Colonies Land Use District Board of Trustees President Tyler Stockman called the regular meeting of the board of trustees to order at 7:00 p.m. Present in person: Joe Parcell, Tyler Stockman, Emilie Hoppe, Bruce Trumpold, Lynn Trumpold, Peter Hoehnle, Norine Magee.

- III. Review/Approve October 14, 2024 Regular Meeting minutes: Hoppe made a motion to approve October meeting minutes. 2<sup>nd</sup> by Hoehnle. Motion passed unanimously.

- V. <u>Discussion/Action on the following permit applications in a Historic Preservation Zoning District:</u>
  - a. 2024-088 Joel Graesser / 1011 25th Ave. Middle Amana / HP-R / Hang new K-style gutters on entire house. Replace 6 basement windows. Repair fascia board and install white fascia covering. Hoppe made a motion to approve the application as presented.
    2<sup>nd</sup> by Magee. Motion passed unanimously.
  - b. 2024-090 Jason Miller / 4105 V St. Homestead/ HP-C / Repair foundation no changes to appearance. Tear siding off replace with approved vinyl color. Replace the steel core double door on the East side with sliding glass doors. Tear off the East side porch and replace it with a deck. Rebuild the front porch to match existing structure. Add an Amana compliant fence on the west and south side of property. General repairs to Alma's Washhouse, no change to appearance. Repair windows and replace them with vinyl. Replace current siding with Lap Siding/wood composite instead of vinyl. Sliding steel core double door on E porch. East side porch as long as deck size and material are presented to BOT. Front porch as long as it stays consistent with original structure. Wood fence to be Amana compliant as presented. Replacing 34 windows with vinyl if replaced like for like. Repairs to the wash house if there is no change to appearance minus replacement of the steel door with an Amana wood style door. Hoppe made a motion to approve foundation repairs as presented. 2<sup>nd</sup> by Magee. Motion passed unanimously. Hoehnle made a motion to approve repairs to Almas Wash House as presented. 2<sup>nd</sup> by B. Trumpold. Motion passed unanimously. Hoppe made a motion to approve the wood fence as presented. 2<sup>nd</sup> by Hoehnle. Motion passed unanimously. Hoppe made a motion to table the siding, windows, and East porch till we have more information. 2<sup>nd</sup> by Norine. Motion passed unanimously.

HPC recommended approval on condition that a plan is in place and that the silhouette of the chimney does not change. - d. 2024-092 Josh and Melena Wickenkamp /609 15th Ave. Amana / HP-R / Build 50X30 garage. Side house with approved color in vinyl. Replace 9 windows. Motion passed unanimously. - e. 2024-059 Jeff and Suzanne Conquest / 621 46<sup>th</sup> Ave Amana / HP-C / Replace all current K-style gutters and downspouts with Amana-compliant galvanized half-round gutters and round downspouts on both house and garage. Hoehnle made a motion to issue the check. 2<sup>nd</sup> by Parcell. Motion passed unanimously.
